CONTRIBUTIONS AND CONSUMER'S USE TAX

This schedule may be used to pay consumer's use tax and make voluntary donations to certain organizations as authorized by the General Assembly. Read the instructions below for information on limitations that apply. If you want to make other donations to these organizations or would like additional information, see the instruction book. *The amounts you enter on this schedule will reduce your refund or increase the amount you owe on Form 760.*

Voluntary Contributions:

The amounts you enter for the organizations listed on lines (a)-(j) may not be greater than the refund you are otherwise eligible to receive, but donations of any amount may be entered on line (l) for the Chesapeake Bay Restoration Fund and line (m) FACT, Family and Children's Trust Fund, even if you are not due a refund. If any additional payment is required for your Chesapeake Bay Restoration Fund and Family and Children's Trust Fund contribution(s), it will be included in the computation of the amount you owe on Form 760.

Consumer's Use Tax:

If you purchased more than \$100 in goods during the taxable year from businesses that did not charge you sales tax, you must pay the consumer's use tax on the total amount of those purchases. The tax is 4 1/2% of what you paid for the item, excluding any separately stated shipping charge. For more information, see the instruction book. Do not file Form CU-7 if you include the amount of consumer's use tax you owe on Form 760.
