Overview

Virginia's <u>eForms</u> system is a free and secure system using **fillable electronic forms** to electronically file your wage and tax statements to the Virginia Department of Taxation (Department).

This means you key your W-2 or 1099 information into the eForm and submit it electronically to the Department. eForms allow you to file directly from your web browser, all without signing up.

The eForms W-2 – 1099 Guide will explain:

- How Authentication works via the Business iFile and eForms systems
- How to use eForms to file your W-2 and 1099 data
- How to save and/or print a summary of your data as an Adobe PDF (image document)

New This Year

To report a corrected W-2, Wage and Tax statement, the W-2C is available to file this year. This form will follow the same authentication process as the W-2 and 1099s. Employer Identification Number (EIN) changes or wrong tax year corrections will not be allowed in eForms; however, you can get eForms assistance by using this <u>link</u>. If you have filing questions or account specific inquiries, please contact Customer Services at (804) 367-8037.

Authentication Requirements

Before using eForms to key in wage statement data, you are required to authenticate the business for which you are filing. There are two ways to do this and access the applicable W-2 or 1099 eForm.

- 1. Access directly from the eForms homepage, or
- 2. Access after logging in to your Online Business Accounts account

Authentication ensures that only those individuals who are authorized to access the account data may do so. If invalid information is entered there will be a message advising that the information is incorrect. For assistance, please contact Customer Services at (804) 367-8037.

NOTE: After 6 attempts, you are locked out for 24 hours and cannot try again to file until the 24 hours is up.

eForms Homepage

The <u>eForms</u> Homepage does not require a separate sign-up. Instead, you are required to authenticate the specific business by providing the following information.

- The Employer FEIN (and account suffix)
- The Tax Year for which you are filing
- The total amount of withholding tax paid to the Virginia Department of Taxation during the filing year

NOTE: The total amount of withholding tax paid is the sum of all payments made in the taxable year and does not include penalty or interest paid.

Business iFile Account

Logging in through an <u>Online Business Accounts</u> account will address the authentication required to use the W-2 eForms. There are two ways to access the applicable eForm, when logged into Business iFile.

- 1. Click "File and/or Pay Tax Returns and Payments" and select the eForms option for the specific W-2, 1099-R or 1099-MISC eForm.
- 2. Select the eForms option from the VA-6 (or VA-6H) confirmation page.



Entering W-2, 1099-R, 1099-MISC or 1099-NEC Data

Once you access the eForm and authentication is complete, you will be able to manually enter your data onto the eForms screens.

Regardless of your authentication method, the same screens are displayed for you to key in the wage statement data.

- Employer Information demographics for the employer or payer, FEIN and tax year
- Employee Information entries for each employee or payee

Also, please remember these details:

- You can enter up 100 employee records at a time.
- Always confirm that the correct tax year is displayed for the wage statement data.
- You will see a total calculated for you, please verify it is correct before submitting.
- When you click Next Step, you will see this message:



Once you select "OK", review your filing again and if changes are needed, select "Make Changes"; otherwise, you select "File Now".

Entering W-2C Data

The W-2C eForm will be used for the following types of corrections:

- Correcting the Employee's Social Security Number (SSN)
- Correcting the Virginia State Wages
- Correcting the Virginia State Tax Withheld

NOTE: For corrections to the Employer Identification Number (EIN) or if you filed your W-2 with the wrong year, you will need to contact Customer Services at (804) 367-8037 or use iFIle Secure Messaging.

Once you access the W-2C eForm and authentication is complete, you will be able to manually enter your data onto the eForms screens.

Regardless of your authentication method, the same screens are displayed for you to key in the wage statement data.

- Employer Information demographics for the employer or payer, FEIN and tax year
- Employee Information entries for each employee or payee

Also, please remember these details:

- You can enter up 100 employee records at a time.
