# Virginia Free Fillable Forms Quick Reference Guide – How to Resolve Errors

## **Error Messages**

If your return is missing information or some of that information is incorrect, the Fillable Forms program will reject your return. The program will email the error message(s) of why it was rejected.

This type of message is also known as a **schema validation error**.

"Schema Validation Error VAFORMS-004 - Document does not pass the schema validation..."

You must take action to fix this error in order to submit your return to Virginia Tax. Your return will need:

- correct information you entered into the Fillable Form 760 and/or
- complete missing information not entered

## **Example of Messages / Keywords**

There are multiple parts to each error message. Using the Find / Search function with unique words in the message will help you narrow down to a solution that helps you.

When you search, focus on using only a few keywords at a time. Do not use the whole message.

Generally, unique text starts after "Document does not pass the schema validation. Error:...". In this Guide, unique keywords are noted in red for your convenience.

Document does not pass the schema validation. Error: The element 'Form760CG' in namespace 'http://www.irs.gov/efile' has invalid child element 'FilingStatus' in namespace 'http://www.irs.gov/efile'. List of possible elements expected: 'FillInAllOvalsThatApply, LocalityCode' in namespace 'http://www.irs.gov/efile'.

For this example you could use: FilingStatus, or FillInAllOvalsThatApply, or LocalityCode.

#### **How to Search for Error Solution(s)**

If you have trouble locating your error message / solution, use one of these search functions to help find it.

- Ctrl key and F key
- Cmd key and F key
- 1. Enter one of unique keywords in the search box.
- 2. Hit the "Enter" key until your message is in the results.
- 3. Repeat the process as needed using the unique key words.
