### VK-1 Consolidated – PTE Tax Schedule Summary

Attention: All PTE Tax VK-1 schedules must be made electronically.

Paper schedules are only allowed for customers with an approved waiver. PTET returns and schedules must be filed electronically.

PTEs reporting 10 or more owners must use this Consolidated form, which allows multiple VK-1 owners to be reported on one summary sheet while maintaining the taxpayer disclosure agreement. This version of the form **may only be used with paper submissions** with approved waivers and PTE must not send the summary sheet(s) to its owners due to the taxpayer's disclosure agreement.

Users must adhere to the requirements set forth in this document and in the Excel template and the PDF versions of the VK-1 Consolidated form. This includes formatting, page orientation, column widths, row heights, etc.

### Special Notes

- Barcode Yes; barcodes are provided in the Excel template and PDF versions of the VK-1 Consolidated form.
- Printing the print area must be set to include the entire form layout.
- Rounding Yes; the length of the numeric fields includes the 2 places for the cents.
- Neither the FEIN nor the SSN field may contain dashes or hyphens (-).
- Review the consolidated instructions provided via the <u>main Forms page</u> when computations are required, when codes are required and/or when amount/numbers must be transferred to/from another form.
